# With every La-Z-Boy product you receive the famous warranty, one of the best in the industry.

To receive service on your product, please contact the authorised retailer from whom you purchased it. Proof of purchase will be required. La-Z-Boy warrants this product to the original consumer purchaser as follows:

**1** The frame comprises the wooden frame, seat springs and rocker springs, where applicable. This does not include pocket springs encased within a foam seat interior.

Metal reclining/inclining mechanisms, frame parts and springs have a limited warranty against manufacturing faults and defects in materials used for 10 years from the delivery date to your retailer.

Reasonable repair or replacement of defective parts will be made within 10 years at no cost to you.

**2** The following have a limited warranty against manufacturing faults and defects in materials used for 2 years from the delivery date to your retailer:

- Electrical motors
- Electrical components
- Electrically operating lifting and rolling mechanisms
- Heated seat function

- Power lumbar support
- Power head tilt
- Power console units (including features within console units)
- Screens
- Speakers
- USB-A / USB-C ports
- Vibration / Massage

Reasonable repair or replacement of defective parts will be made within 2 years at no cost to you.

**3** Padding and foam have a limited warranty against defects under normal domestic use for 24 months from the delivery date to you.

**4** Fabric and leather have a limited warranty against defects under normal domestic use for 24 months from the delivery date to you.

Covers must be cleaned as outlined in the Upholstery Care Guide. Please note, the warranty does not cover defects arising from negligence or misuse such as soiling, fading, wrinkling, creasing, accidents or imprudent cleaning.

Please refer to the Upholstery Care Guide for recommended covering care treatments. Application of upholstery protection will invalidate this warranty.

Warranty coverage applies only to defects in products that are used exclusively for personal, family or household purposes by the original purchaser. It does not cover rental, business, commercial, medical aid or institutional uses. The warranty does not extend to damage resulting from accident, misuse, abuse, or abnormal use.
